Nominating and Judging Process

Individuals and businesses are encouraged to apply directly for these awards. In addition, businesses or individuals may nominate other members of the community who have had notable achievements over the past year. The aim of these awards is to recognize and celebrate the success of individuals and businesses operating within the LoDo District, or whose project/interest has directly impacted the District.

Nominees for the awards will be evaluated based on the nomination rationale and the judging panel may rely on published information and facts that are in the public domain when considering entries. Short-listed businesses or individuals may be asked to provide verification of claims made. Entries should relate to activity falling within the 2011 calendar year. Nominees may enter as many of the award categories as they wish but they may only make one entry in each category. The final award winners are determined by a vote of the LoDo District, Inc. Board of Directors.

Rationale: To reward individuals or businesses who have made a commitment to service to the neighborhood through a significant philanthropic contribution or community involvement.

LEGACY AWARD

Rationale: To recognize and encourage individuals or businesses that demonstrate best practices in the fields of development, renovation or preservation through design, landscape design or architecture and have clearly and successfully demonstrated a contribution to the visual, social, and cultural life in the community.

SPOTLIGHT AWARD

Rationale: To reward individuals or businesses that are marketing driven and to reinforce the overall community impact of a well directed marketing campaign or event that helps positively drive activity to the area.

SERVICE AWARD

Rationale: To reward individuals or businesses that demonstrate dedication to the organization and go above & beyond the call of duty to volunteer their time and talents to help strengthen the LoDo District, Inc., its causes and its membership.

NEW BUSINESS AWARD

Rationale: To recognize a business who joined the LoDo neighborhood in 2010 and has made a positive and notable impact.
